WAIVER OF EQUINE ACTIVITY LIABILITY 2021

I, _____, acknowledge that, pursuant to Ohio Revised Code (ORC) 2305.321, by participating in mounted activities sponsored by Flatlanders Dressage & Combined Training Association, Inc. (FDCTA/Flatlanders) including, but not limited to, trail rides, clinics, shows, camp, I am an equine activity participant for the 2021 season commencing on the first day of January 2021 and continuing through the thirty-first day of December 2021.

As an equine activity participant, I am subject to the inherent risk of an equine activity as defined in Ohio Revised Code 2305.321, meaning danger or condition that is an integral part of an equine activity, including, but not limited to, any of the following:

- A. the propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine;
- B. the unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals;
- C. hazards, including, but not limited to, surface or subsurface conditions;
- D. a collision with another equine, another animal, a person, or an object;
- E. the potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant.

By signing this written waiver, I acknowledge that the equine participant who is the subject of this waiver, as well as the parent, guardian, custodian, or other legal representative of the equine activity participant who is the subject of the waiver, does not have a claim or cause of action upon which a recovery of damages may be based against, and may not recover damages in tort or other civil action against, any and all equine activity sponsors, another equine activity participant, equine professionals, veterinarians, farriers, or other persons associated with this activity, including but not limited to Flatlanders Dressage & Combined Training Association (FDCTA), Inc., its officers, directors, trustees, members, patrons, guests, and/or landowners upon whose land FDCTA hosts activities.
